Overview

5 of NFPA 855, we learn that individual ESS units shall be separated from each other by a minimum of three feet unless smaller separation distances are documented to be adequate and approved by the authority having jurisdiction (AHJ) based on large-scale fire testing. As the adoption of large-scale energy storage power stations increases, ensuring proper equipment layout and safety distances is crucial. These facilities house essential components such as battery containers, Power Conversion Systems (PCS), and transformers. 4kV and above, a rated power of 500kW and above, and a rated energy of 1000 kWh and above. NFPA 855 sets the rules in residential settings for each energy storage unit--how many kWh you can have per unit and containerized battery energy storage system?
